

Programme description

LECTURE

Duration: 2:00h

Executive conversation

Duration: 0:45 - 1:00h

The second part is centered on the lecturers and their message and advice to the students for personal and professional development.

*The conversation is assisted by a moderator from the faculty;

Students are always interested in success stories, thus the conversation should include the personal story of the lecturer and his/her career story.

Main questions for the conversation are:

1. How the lecturer chose a career in their respective field;
2. What challenges the lecturer faced and how he/she overcame them;
3. Examples for success stories in the lecturer's career;
4. What makes a great professional in the respective field;

Final stage of the Executive conversation is a Q&A session where students can address the lecturer explore further certain topic.
